

## Sarasota County Bar Association Website Enhanced Listing

The newly redesigned website of the Sarasota County Bar Association will include a basic online membership directory available to the public. Members may elect to purchase a searchable/enhanced listing that will include up to three areas of practice and a link to their firm's website. A special introductory rate of \$25.00 is being offered through September 30. Beginning October 1, the rate will be \$35.00. This enhanced listing feature will be renewable on an annual basis.

The online membership directory will allow users to search for attorneys within chosen practice areas; however, only members purchasing enhanced listings will be listed under the practice area search results.
